TERMS OF ENROLLMENT initial \_\_\_\_\_

I understand and agree to the following:

1. Enrollment is for a continuous period from Sept. 12, 2011 - June 15, 2012\*.
2. Classes are subject to change based on enrollment. Sole determination of placement rests with Joan Izzo.
4. The monthly tuition for these classes is \$\_\_\_\_\_ to be paid by the first lesson of the month.
5. Tuition is non-refundable. In the event of serious injury or illness, credit can be extended for future classes.
3. A —late fee|| will be applied to any unpaid balance on the 10<sup>th</sup> of the month.
4. Tuition for September & June\* and a non-refundable registration fee (\$25 per student) are due at enrollment.
5. A fee of \$25 will be assessed for each returned check.
6. A \$40 costume deposit (per costume) is due on December 10, 2011. The balance(s) is due on April 10, 2012.
7. A \$85 recital fee is due April 10, 2012 (\$50 for each additional student in family). No fee for In-House recitals.

\*Pre-paid June tuition is not refundable after a student has been enrolled in classes for more than 6 weeks.

## Conditions of Enrollment & Responsibility

1. I agree to accompany my child(ren) into the building for dance classes.
2. I agree to pick-up my child(ren) promptly after class.
3. I agree to directly supervise siblings/other children I bring into the studio and clean-up after them.
4. I understand that I will be required to be a Parent Helper 3 - 4 times during the year if my child is in a class prior to 4:00 p.m. This involves assisting the children with bathroom breaks.
5. I understand there will be two observations during the year (one is held mid-year in December or January and the other will be the spring recital, held either In-House or on-stage) and that parents are always welcome to observe classes. I understand that I need to contact Joan Izzo if I would like to observe at any time other than scheduled observations.
6. I understand that participation in the annual recital is optional, and will require costumes and recital fees as mentioned on the front of this form. For classes with In-House recitals, there are no recital fees; however, costume fees do apply.
7. I understand that attendance at the spring recital run-through(s) and dress rehearsal(s) is mandatory, no exceptions.
8. I understand that the dates for recital costume pick-up and ticket sales will be posted at the studio and noted in advance in the newsletter; and I will need to pick-up costumes and purchase tickets on those dates. If I cannot make any of these dates, I will make arrangements for someone else to pick-up my child's costume(s) and/or purchase my tickets.
9. I understand there will be a storage fee for costumes not picked-up on the posted pick-up dates.
10. I understand that the annual tuition fee is calculated and divided evenly into 10 monthly payments and therefore the monthly amount I am invoiced will remain the same no matter how many weeks of classes there are in a given month. I also understand that tuition will not be pro-rated due to missed classes due to inclement weather, holidays, student vacations, rehearsals, or performances.
11. I understand and accept the registration fee, tuition payment schedule, and late payment fee of \$20 charged after the 10<sup>th</sup> of each month.
12. I agree to pay a \$25 returned check fee for every returned check, regardless of reason.
13. I understand that it is my responsibility to make sure I receive and read my monthly invoices and newsletters so that I will be aware of what is required of me and my child.
14. I understand that the studio will follow the inclement weather policy for Fairfax County Schools—if schools are closed or activities at the school are cancelled, the studio will be closed.
15. I understand that the Joan Izzo Academy of Dance will not be held responsible for lost or stolen articles.
16. I acknowledge that my child is physically capable of participating in dance training.
17. I understand that the Joan Izzo Academy of Dance staff, instructors or their landlords are not responsible for injury to myself or my child, whether based on allegations or not, by any reason of my or my child's participation in classes, rehearsals, or performances.
18. I understand and accept that dance instruction may require an instructor to physically touch a student during class.
19. I understand that all instructors will follow safety procedures. In the event of injury every effort will be made to contact the parent or guardian of the student. If necessary, I authorize the staff to administer first aid and/or request emergency medical treatment.
